#### 15 Description of Product

Type A42SCR Restrained Plug Coupler, rated at up to 250A, 650/1300V. The coupler comprises a brass and gunmetal enclosure, incorporating an insulator assembly with three main contact pins and a pilot circuit contact pin.

A location pin in the coupler body enables the contact pin assembly to be set in the 650v or 1300V mode.

The coupler has a mounting at each end for restrained plugs or restrained test plugs, suitably certified for Group I use, in accordance with EN IEC 60079-0: 2018 and EN 60079-1: 2014, having a flameproof interface as BS5620.

The socket body is provided with holes for a padlock
