Type A40SR Restrained Socket, rated at up to 350A, 650V/1300V. The plug comprises a brass and gunmetal enclosure, incorporating a cable gland assembly, an insulator assembly with three main contact pins, one pilot circuit contact pin and an earth contact.

The power and pilot contact pins are fitted with grub screws for cable core connection.
