Type A43SCB Bolted Plug Coupler, rated at up to 500A, 3300V. The coupler comprises a gunmetal enclosure, incorporating an insulator assembly with three main contact pins, one pilot circuit contact pin and two auxiliary pins.

The coupler has a mounting at each end for bolted plugs or bolted test plugs, suitably certified for Group I use, in accordance with IEC 60079-0: 2017 and IEC 60079-1: 2014, having a flameproof interface as BS 5620.
