### 13 Description of Component

**Type A42TPR Restrained Test Plug**, for use in association with a socket as Baseefa02ATEX0104U or a plug coupler as Baseefa02ATEX0105, or any connector suitably certified for Group I use in accordance with EN 50014 and EN 50018, having a flameproof interface as BS 5620, rated at up to 250A, 1300V.

The plug comprises a brass and gunmetal enclosure, incorporating an insulator assembly which includes a pilot circuit contact tube, a resistor and a rectifier assembly. The unit contains a contact assembly which is operated by a through-going push/pull button.
